# **OUR POLICY**

Willow Point Golf & Country Club is licensed by the Alcohol Beverage Control (ABC) Board of the State of Alabama to sell and dispense alcoholic beverages as a private club. The Club is responsible for adhering to all the rules and regulations of the ABC Board as well as other laws of the State in selling alcoholic beverages. Failure to comply with these laws could result in the loss of the Club's liquor license as well as in the imposition of civil liability. For these reasons, management and employees must strictly enforce and comply with all these rules and regulations.

The Club will not sell or serve alcoholic beverages to minors. We will not permit the consumption of alcoholic beverages by minors on the premises. All members and guests shall not permit their underaged children to consume alcoholic beverages at the Club.

Minors are welcome everywhere except for the Oak Room, considered the main bar.

No intoxicated person will be served alcoholic beverages at the Club. The Board of Directors empowers the Club's management and staff to determine whether a member or guest is intoxicated. Once intoxication is determined, Club management and staff have the right to refuse the service of alcoholic beverages and are empowered to take whatever action necessary for the safety of that individual.

Personal coolers containing outside food or beverage of any kind are not permissible on Club grounds without the approval of Club management. The Club will have coolers available for all members and guests and will require storage of food and beverages purchased outside the Club while on the grounds.
